WHAT'S IN THE LEVEL 1 INDUCTION

The Level 1 induction is the base induction and has four (4) parts that provide a general understanding of local government and safety in the workplace.

PART A Working with Local Government

Local Government has extensive Governance, accountability and compliance standards that have to be observed.

This section explains why working for local government is different to the public sector and covers:

- What is local government
- Working with the public
- Working as an employee, contractor or volunteer

PART B Your State Legislation

Local Government and everyone who works with local government is required to comply with the law.

This section looks at specific state:

- Legislation
- Regulations
- Standards
- Codes of practice

that applies to employees, contractors and volunteers.

PART C Workplace Safety

This section covers:

- OHS requirements.
- Identifying hazards and controls measures.
- OHS Communication at the workplace.
- Emergency incident response procedures.

PART D Working with the Environment

Working in an environmentally aware way is very important. This section looks at:

- The legal and personal responsibility.
- Assessing environmental impacts before work.
- Managing incidents and reporting.
- Heritage management.

WHAT IS IT?

The **National Local Government Level 1 Induction** has been developed to address the unique and specific needs of local government and government authorities including water and sewage. The training is a general induction and is the first step in the three levels of induction recommended by statutory authorities.

How Level 1 Fits into a Local Government Induction Process

Occupational Health and Safety Legislation, Acts, Regulations, Codes of Practice clearly state the duty of care requirement of instruction to employees and contractors, known as induction. At a minimum the training should provide detail of workplace policies, procedures, emergency management, risk management, hazard identification and control strategies at the workplace. To accomplish this a three stage induction process is considered appropriate in most workplaces.

Contractors

You are responsible for the safety of your employees and sub contractors. The National Local Government Level 1 Induction provides details on local government and government authorities. The training will give you an overview of the systems and processes you will be required to comply with and the occupational health, safety and environmental hazards and control strategies used by this unique business sector.

The Level 1 Induction has been developed to **reduce the amount of time and cost contractors spend at induction** by developing a fully transportable induction across the local government sector.

Additional benefits include the recognition of the **Construction Industry White Card**. If a person holds a Construction Industry WHITE CARD an exemption and fee discount applies for Part C of the induction for two years from the issue date.
